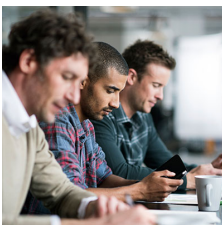

2018/19 Workplace Inspection Blitzes & Initiatives

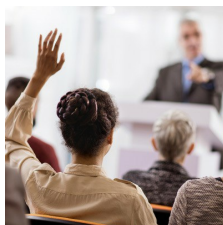
