Roundtable (all members)	<p><u>Ian Nash:</u></p> <ul style="list-style-type: none"> - Consider going to 4-gas meters for danger of hydrogen sulphide - Flooding concerns – rainboots issued - Mental health issues are a big concern - Hiring 18 more Paramedics, hard to find staff right now - Service uses Dottie Belt to help move patients <p><u>Isaac Arnold:</u></p> <ul style="list-style-type: none"> - 384 COVID transports last month - Conducting noise assessment of new sirens - Preparing for general noise assessment <p><u>Dave Doran:</u></p> <ul style="list-style-type: none"> - Doing study using TWA for Noise & CO testing - Just rolled out 'victory' sprayer to disinfect the stations (handheld) - Rolled out 'hover jack' to lift larger patients off the ground – looking to purchase second unit - 2 Paramedics were physically assaulted, suggested self-defence training, created Violence Against Paramedics Committee - Trying to address concerns with IV pumps when doing transfers - Advocating for driver refresher training <p><u>Chris Stolte:</u></p> <ul style="list-style-type: none"> - Expecting 2 new ambulance by end of year - 2 mustang life jackets will be supplied in each ambulance in the county. Where the "one size fits all" does not accommodate the individual paramedics. Those paramedics will be issued their own personal life jacket - 'Victory' sprayers in use in stations and trucks - New Manager appointed in Lambton <p><u>Rob Crossan:</u></p> <ul style="list-style-type: none"> - Samples of new Binder Lifts, for patients on the floor (evidence shows injuries are coming from this level) - UV light system is used in vehicles for 20 minutes at a time <p><u>Wayne Markell (the best, saved for last of course):</u></p> <ul style="list-style-type: none"> - Received two new Ford F350's – had 3 occurrences of lost steering and braking while on Code 4 response – no clamps on high pressure lines was found to be the cause. Transport Canada has inspected the vehicles. We have received an affidavit from Ford that vehicles are safe to use. Transport Canada has taken some parts for inspection. - Issues with responding to call volumes in Ottawa – response protocols will change on September 12th
